

**City of West Point
Special Council Meeting Minutes
April 25, 2022**

Mayor Billy Ash called the meeting to order at 6:00 PM. Present were: Mayor Billy Ash, City Clerk/Treasurer Gaye Moore, and Council members: Joseph Frost, Annette Baker, Fran Moore and Richard Ciresi

Mayor Ash stated the water tower contract time will be up May 21, 2022. We did find out we can use the ARPA money to paint the water tower.

Richard Ciresi made a motion to use the ARPA money to paint the water tower. Joseph Frost asked if we can put this off until we know if the Hardin Co Water deal goes through? Can we fill the tank to use it as a back-up for water?

Mayor Ash stated if we paint the inside of the tank, it could cost another \$75,000.00.

Joseph Frost asked what the warranty was on the tank, Richard Ciresi stated it could 10-15 years.

Annette Baker asked if we could possibility add more cell companies to the tower. Richard Ciresi stated we don't know in five years if they will be around or not. Mayor Ash stated the contracts state either party can leave with a 45-60-day notice. We are responsible to keep the tank maintained. If we don't paint it on this bid, we may not get bids on it again. Joseph Frost asked, if the fire truck situation was ok before we spend this money on the water tower? Mayor Ash stated we have mutual aid and a fire truck to use from Radcliff. Joseph Frost seconded the motion. Joseph Frost, Annette Baker, Fran Moore, Richard Ciresi all voted yes. Motion passed.

Richard Ciresi read the second reading of Ordinance 2022-03 Establishing a Code Enforcement Board.

Richard Ciresi made a motion to accept Ordinance 2022-03, Fran Moore seconded the motion. Joseph Frost asked if we have contacted Habitat for Humanity to help with repairs. Mayor Ash stated they have been down here but that as far as it went. Joseph Frost, Annette Baker, Fran Moore and Richard Ciresi all voted yes. Motion passed.

Mayor Ash stated the 2016 Police cruiser did not meet the reserve on govdeals. Richard Ciresi stated we are going to have to sell the cruiser to meet the budget. Richard Ciresi made a motion to relist the police cruiser for 10 days on govdeals and state the reserve. Joseph Frost, seconded the motion. Joseph Frost, Annette Baker, Fran Moore, Richard Ciresi all voted yes.
